On March 2, 2017, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant") filed a verified application pursuant to § 34-60-116 C.R.S. for an order to:

1) Pool all interests one approximate 360-acre horizontal wellbore spacing unit, and two approximate 400-acre horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Niobrara Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of § 34-60-116(7), C.R.S. effective as of the earlier of the date of the Application, or the drilling of the Elbert 1N well (API No. Pending), the Elbert 2N well (API No. Pending), and the Elbert 3N well (API No. 05-123-44328).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the permitted well locations in accordance with the provisions of Order No. 407-1.


