On March 2, 2017, Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate Order No. 407-1775 which pooled all interests in two 720-acre horizontal wellbore spacing units, for the development and operation of the Codell and Niobrara Formations, for the drilling of the CS-Bittersweet C1-1-13 well and the CS-Bittersweet 3-1-13 well;
- 2) Pool all interests in two approximate 800-acre designated horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Codell Formation ("WSU No. 1") and the Niobrara Formation ("WSU No. 2"); and
- 3) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the CS-Bittersweet C1-1-13 well (API No. 05-123-42936), estimated spud date third quarter 2017, for the production of oil, gas and associated hydrocarbons from the Codell Formation (WSU No. 1), and the CS-Bittersweet 3-1-13 well (API No. 05-123-42937), estimated spud date third quarter 2017, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation (WSU No. 2).
