APPLICATION

On March 2, 2017, Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Vacate Order No. 407-1774 which pooled all interests in six 720-acre horizontal wellbore spacing units, for the Codell and Niobrara Formations and subject all nonconsenting interests to the cost recovery provisions of Section 34-60-116(7), C.R.S., for the CS-Scott C4-1-13 well (API No. 05-123-42914), CS-Scott 5-1-13 well (API No. 05-123-38820), CS-Scott 4-1-13 well (API No. 05-123-38822), CS-Scott C3-1-13 well (API No. 05-123-42910), CS-Scott 3-1-13 well (API No. 05-123-38825), and the CS-Scott C2-1-13 well (API No. 05-123-42908);

2) Pool all interests in six approximate 800-acre designated horizontal wellbore spacing units ("WSU") established for the development and operation of the Codell Formation ("WSU Nos. 1, 4, and 6") and the Niobrara Formation ("WSU Nos. 2, 3, and 5"); and

3) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the following wells, each with an estimated spud date in third quarter 2017:

**WSU No. 1:** CS-Scott C4-1-13 well (API No. 05-123-42914), to produce oil, gas and associated hydrocarbons from the Codell Formation;

**WSU No. 2:** CS-Scott 5-1-13 well (API No. 05-123-38820), to produce oil, gas and associated hydrocarbons from the Niobrara Formation;

**WSU No. 3:** CS-Scott 4-1-13 well (API No. 05-123-38822), to produce oil, gas and associated hydrocarbons from the Niobrara Formation;

**WSU No. 4:** CS-Scott C3-1-13 well (API No. 05-123-42910), to produce oil, gas and associated hydrocarbons from the Codell Formation;

**WSU No. 5:** CS-Scott 3-1-13 well (API No. 05-123-38825), to produce oil, gas and associated hydrocarbons from the Niobrara Formation; and

**WSU No. 6:** CS-Scott C2-1-13 well (API No. 05-123-42908), to produce oil, gas and associated hydrocarbons from the Codell Formation;
