NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

APPLICATION

On March 2, 2017, Bill Barrett Corporation ("BBC" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order:

1) Vacating an approximate 640-acre drilling and spacing unit established for Section 12, Township 1 North, Range 64 West, 6th P.M. by Order No. 407-514 and 535-104, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.

2) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands and approve up to 16 horizontal wells in the unit, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with the productive interval of any horizontal well to be no closer than 460 feet from the unit boundaries, and not less than 150 feet from the productive interval of another well within the unit, unless an exception is granted by the Director; and

2) Require that the approved wells be located on no more than four new well pads within the unit, or adjacent thereto, unless an exception is granted by the Director.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which, among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with permitted well locations in accordance with the provisions

of Order No. 407-1. The Application Lands are subject to this Order for the Codell and Niobrara Formations.

- On December 12, 2011, the Commission entered Order No. 407-514 and 535-104 which, among other things, established seven approximate 640-acre drilling and spacing units for lands including Section 12, Township 1 North, Range 64 West, 6th P.M.; and approved one horizontal well within each unit, regardless of lease lines within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the surface location of the permitted well to be located on the surface anywhere within the proposed unit and the treated interval of the wellbore for the permitted well to be no closer than 600 feet from the unit boundaries, for lands subject to Rule 318.a., and no closer than 460 feet from the unit boundaries for lands subject to Rule 318A, without exception being granted by the Director.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 17, 2017.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
