APPLICATION

On March 2, 2017, amended March 16, 2017, Carrizo Oil & Gas, Inc. (Operator No. 10338) and Carrizo (Niobrara) LLC (Operator No. 10439) (together, "Carrizo" or "Applicant"), filed a verified application pursuant to C.R.S. § 34-60-116, for an Order to:

- 1) Amend Order No. 535-691 to include the Codell formation in the approximate 320-acre drilling and spacing unit previously established for the Application Lands;
- 2) Approve the development of a maximum of 16 horizontal wells within the approximate 320-acre drilling and spacing unit for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell formations on the Application Lands.

- On March 8, 2011, the Commission entered Order No. 535-3, which, among other things, established an approximate 640-acre drilling and spacing unit for Section 27 for the production of oil, gas, and associated hydrocarbons from the Niobrara formation, and approved up to one (1) horizontal well within the unit.
- On September 22, 2015, the Commission entered Order No. 535-691, which, among other things, established an approximate 320-acre drilling and spacing unit for Section 27: N½ for the production of oil, gas, and associated hydrocarbons from the Niobrara formation, and approved up to 16 horizontal wells within the unit. Order No. 535-691 did not explicitly vacate Order No. 535-3, but had the presumptive effect of vacating Order No. 535-3 insofar as Order No. 535-3 covers Section 27: N½.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 17, 2017.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
