APPLICATION

On March 2, 2017, amended March 16, 2017, Carrizo Oil & Gas, Inc. (Operator No. 10338) and Carrizo (Niobrara) LLC (Operator No. 10439) (together, "Carrizo" or "Applicant"), filed a verified application pursuant to C.R.S. § 34-60-116, for an Order to:

- 1) Amend Order No. 535-689 to include the Codell formation in the approximate 640-acre drilling and spacing unit previously established for the Application Lands;
- 2) Approve the development of a maximum of 32 horizontal wells within the approximate 640-acre drilling and spacing unit for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell formations on the Application Lands.

- On September 22, 2015, the Commission entered Order No. 535-689, which, among other things, established an approximate 640-acre drilling and spacing unit for Section 30 for the production of oil, gas, and associated hydrocarbons from the Niobrara formation, and approved up to 32 horizontal wells within the unit.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 17, 2017.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
