APPLICATION LANDS:

Township 1 South, Range 67 West, 6th P.M. Section 10: W½

<u>APPLICATION</u>

On April 13, 2017, Petroshare Corp. (Operator No. 10454) ("Petroshare" or "Applicant") filed a verified application pursuant to § 34-60-116, C.R.S. ("Application"), for an order:

- 1) Pooling all interests in an approximate 320-acre drilling and spacing unit comprised of the Application Lands for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara Formation:
- 2) Providing that the pooling order is made effective as of the earlier of the date of the Application, or the date that any of the costs specified in C.R.S. § 34-60-116(7)(b) are first incurred for the drilling, completion and operation of a horizontal well to the Codell-Niobrara Formation within the Application Lands; and
- 3) Providing that the interests of any owners with whom Applicant has been unable to secure a lease or other agreement to participate in the drilling, completion and operation of a horizontal well in the Application Lands, are pooled by operation of statute, pursuant to C.R.S. § 34-60-116(6), (7), and made subject to the cost recovery and penalty provisions thereof with respect to any horizontal well drilled to develop the Codell-Niobrara Formation.

 On April 27, 1998, the Commission adopted Commission Rule 318A, which among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all Cretaceous Age Formations from the base of the Dakota Formation to the surface. Commission Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of GWA wells. On December 5, 2005, Commission Rule 318A was amended to, among other things, allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Commission Rule 318A was again amended, among other things, to address drilling of horizontal wells. The Application Lands are subject to Commission Rule 318A for the Codell-Niobrara Formations.

On December 8, 2015, the Commission issued Order No. 407-1590 in Docket No. 151200767, Cause No. 407, establishing the Application Lands as a 320-acre drilling and spacing unit for the production of Codell-Niobrara Formations, and authorized the drilling, completion and operation of up to 7 horizontal wells within the same.
