On April 13, 2017, HRM Resources II, LLC, Operator No. 10548 ("HRM" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in five approximate 640-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara and Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. PC North 1S-66-2928-9NH Well (API No. pending) WSU No. 1;
- b. PC North 1S-66-2928-10CDH Well (API No. pending) WSU No. 2;
- c. PC North 1S-66-2928-11NH Well (API No. pending) WSU No. 3;
- d. PC South 1S-66-2928-12NH Well (API No. pending) WSU No. 4;
- e. PC South 1S-66-2928-13CDH Well (API No. pending) WSU No. 5.
