On May 25, 2017, Incline Niobrara Partners, LP, ("INP" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Amend Order No. 407-1547 insofar as it subjects Applicant and Applicant's interests in the Application Lands to the cost recovery provisions of C.R.S. § 34-60-116(7), and to declare that as to the Litzenberger Wells: a) Applicant is not a nonconsenting party and b) Applicant and its interests in the Application Lands are not subject to the cost recovery provisions of § 34-60-116(7), C.R.S.;
- 2) Ratify and confirm the remaining portions of Order No. 407-1547, specifically, establishment of the drilling and spacing unit, authorization for horizontal wells in the unit, and pooling of all interests in the unit, for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara Formation; and
- 3) Order that Cub Creek comply with Rule 530 prior to deeming Applicant a nonconsenting party as to the Litzenberger Wells, including without limitation, sending accurate well election forms and AFEs for the Litzenberger Wells and to allow Applicant a new 35-day election period specified by Rule 530.

Application Lands; B) authorized the drilling of 19 horizontal wells within the unit; C) pooled all interests in the unit; and D) subjected all nonconsenting interests to the cost recovery provisions of § 34-60-116(7), C.R.S., for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara Formation.
