APPLICATION

On May 23, 2017, Extraction Oil & Gas, LLC, Operator No. 10459 ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in six approximate 640-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Stromberger 2 Well (API No. 05-123-42559) (WSU #1), Stromberger 3 Well (API No. 05-123-42631) (WSU #2), Stromberger 4 Well (API No. 05-123-42561) (WSU #3), Stromberger 5 Well (API No. 05-123-42560) (WSU #4), Stromberger 6 Well (API No. 05-123-42556) (WSU #5), and Stromberger 7 Well (API No. 05-123-42558) (WSU #6).
