On May 23, 2017, amended June 16, 2017, Extraction Oil & Gas, LLC, Operator No. 10459 ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in an approximate 560-acre horizontal wellbore spacing unit, established for the Application Lands, for the development and operation of the NIOBRARA CODELL Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Windsor LV2 1 Well (API No. 05-123-44311) (WSU #1).
