APPLICATION

On May 23, 2017, Extraction Oil & Gas, LLC, Operator No. 10459 ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in six approximate 560-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Windsor LV2 2 Well (API No. 05-123- 44307) (WSU #1), the Windsor LV2 3 Well (API No. 05-123-44312) (WSU #2), the Windsor LV2 4 Well (API No. 05-123- 44308) (WSU #3), the Windsor LV2 5 Well (API No. 05-123- 44309) (WSU #4), the Windsor LV2 6 Well (API No. 05-123-44313) (WSU #5), and the Windsor LV2 7 Well (API No. 05-123- 44310) (WSU #6).
