1) Pool all interests in two approximate 240-acre wellbore spacing units and eight approximate 480-acre wellbore spacing units established for the Fitzsimmons 34N-9HZ Well (API No. 05-123-42013), the Fitzsimmons 34C-9HZ Well (API No. 05-123-42007), the Fitzsimmons 13N-9HZ Well (API No. 05-123-42008), the Fitzsimmons 35C-9HZ Well (API No. 05-123-42014), the Fitzsimmons 19N-9HZ Well (API No. 05-123-42010), the Fitzsimmons 35N-9HZ Well (API No. 05-123-42012), the Fitzsimmons 14N-9HZ Well (API No. 05-123-42011), the Fitzsimmons 36N-W9HZ Well (API No. 05-123-42009), the Fitzsimmons 36N-E9HZ Well (API No. 05-123-42006), and the Fitzsimmons 36C-9HZ Well (API No. 05-123-42015) within the Application Lands, for the development and operation of the Niobrara and Codell Formations.
