On May 25, 2017, Kerr-McGee Oil & Gas Onshore LP, Operator No. 47120 ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in two approximate 240-acre horizontal wellbore spacing units and three approximate 480-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of

the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the FL Mountain 18N-4HZ Well (API No. 05-123-43106) (WSU No. 1); the FL Mountain 4N-4HZ Well (API No. 05-123-43106) (WSU No. 2); the FL Mountain 29C-4HZ Well (API No. 05-123-43104) (WSU No. 3); the FL Mountain 29N-4HZ Well (API No. 05-123-43098) (WSU No. 4); and the FL Mountain 6N-4HZ Well (API No. 05-123-43103) (WSU No. 5).
