APPLICATION

On May 25, 2017, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests within an approximate 640-acre drilling and spacing unit established for the Application Lands.
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of T&M DE 22-039HC Well (API No. 05-123-43241) to the Codell Formation in the approximate 640-acre drilling and spacing unit established for the Application Lands.

- On March 7, 2016, the Commission entered Order No. 535-724 which established an exploratory approximate 640-acre drilling and spacing unit for the Application Lands ("Drilling and Spacing Unit"), among others, with the allowance of one horizontal well to the Codell and Niobrara Formations with the permitted well to be no closer than 330 feet from the boundaries of the unit.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 10, 2017.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
