On June 5, 2017, Synergy Resources Corporation, doing business as SRC Energy, Inc., Operator No. 10311 ("Synergy" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in five approximate 811.886-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Ag 31N-31B-L Well (API No. 44875) (WSU #1), the Ag 31C-31-L Well (API No. 44881) (WSU #2) the Ag 31N-31C-L Well (API No. 44876) (WSU #3), the Ag 4C-31-L Well (API No. 44880) (WSU #4), and the Ag 4N-31B-L Well (API No. 44874) (WSU #5).
