APPLICATION

On August 10, 2017, Bison Exploration, LLC (Operator No. 10646) ("Bison" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands and approve 16 horizontal wells for the production of oil, gas and associated hydrocarbons from the Niobrara Formation; and
- 2) Require the productive interval of the wellbore of any permitted wells in the unit to be located no closer than 600 feet from the unit boundary, and no closer than 150 feet from the productive interval of any other wellbore located in the Niobrara Formation.
- 4) Applicant states that the wells be drilled from no more than two well pads located within the unit, without exception granted by the Director.

APPLICABLE RULES AND ORDERS

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of October 16, 2017, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
