APPLICATION

On August 31, 2017, Kerr-McGee Oil & Gas Onshore LP, Operator No. 47120 ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in three approximate 560-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Putter 27-3HZ Well (API No. 05-123-45130) (WSU No. 1), Putter 27-4HZ Well (API No. 05-123-45135) (WSU No. 2), and the Putter 27-5HZ Well (API No. 05-123-45134) (WSU No. 3).


