APPLICATION

On August 31, 2017, Synergy Resources Corporation, doing business as SRC Energy, Inc., Operator No. 10311 ("Synergy" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in two approximate 360-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Leffler 8C-23-L Well (API No. 05-123-44824) (WSU #1) and the Leffler 8N-23B-L Well (API No. 05-123-44823) (WSU #2).


