APPLICATION

On August 31, 2017, Enerplus Resources (USA) Corporation, Operator No. 10177 ("Enerplus" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands and authorizing the drilling of up to six horizontal wells within the proposed unit, for the production of oil, gas, and associated hydrocarbons from the Fort Hays, Codell, and Carlile Formations, and up to two horizontal wells within the proposed unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara Formation.
 - 2) Providing that setbacks for the Application Lands be as follows:
- a. Any horizontal wells will be drilled from the surface of the drilling unit, or on adjacent lands with consent of the landowner, from no more than two surface locations, unless an exception is granted by the Director.
- b. The wellbores of any horizontal wells may enter the Fort Hayes, Carlile, Codell, and Niobrara Formations anywhere within the unit, or on adjacent lands, without exception being granted by the Director.
- c. The treated intervals of any horizontal wells shall be not less than 150 feet from the treated interval of another well producing from the same formation, without exception being granted by the Director.
- d. The treated intervals of any horizontal wells shall be located no closer than 460 feet from the unit boundary.
