APPLICATION

On August 31, 2017, Bill Barrett Corporation (Operator No. 10071) ("BBC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1. Pool all interests in an approximate 1,280-acre drilling and spacing unit, established for the Application Lands, for the development and operation of the Niobrara Formation; and

2. Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Anschutz Equus Farms 4-62-32-0916C Well (API No. 05-123-43226), the Anschutz Equus Farms 4-62-32-2417C Well (API No. 05-123-43227), the Anschutz Equus Farms 4-62-32-2532C Well (API No. 05-123-43217), the Anschutz Equus Farms 4-62-32-4033C Well (API No. 05-123-43221), the Anschutz Equus Farms 4-62-32-0801CS Well (API No. 05-123-42729), the Anschutz Equus Farms 4-62-32-4148C Well (API No. 05-123-45304), the Anschutz Equus Farms 4-62-32-5649C Well (API No. 05-123-45309), and the Anschutz Equus Farms 4-62-32-5764CN Well (API No. 05-123-45307) ("Wells").

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On June 27, 2011, the Commission entered Order No. 407-560 which, among other things, established 640-acre drilling and spacing units for certain lands, including Section 32, Township 4 North, Range 62 West, 6th P.M. of the Application Lands, and approved

one horizontal well within each unit, for the production of gas and associated hydrocarbons from the Niobrara Formation.

- On April 18, 2016, the Commission entered Order No. 407-1677 which, among other things, vacated an approximate 640-acre drilling and spacing unit established by Order No. 407-560 for Section 32, Township 4 North, Range 62 West, 6th P.M., for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, established an approximate 1,280-acre drilling and spacing unit for Sections 31 and 32, Township 4 North, Range 62 West, 6th P.M., and approved up to 16 horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of October 16, 2017, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
