APPLICATION

On August 31, 2017, amended September 20, 2017, Mallard Exploration, LLC (Operator No. 10670) ("Mallard" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1. Amend an approximate 1,280-acre drilling and spacing unit established by Order 535-529 for the Application Lands to include the Fort Hays, Carlile, and Codell Formations; and
2. Approve up to 16 horizontal wells, within the unit, with 12 horizontal wells to be drilled to the Niobrara Formation and four horizontal wells to be drilled to the Codell Formation. The productive interval of each wellbore shall be located no closer than 600 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located within the unit, without exception being granted by the Director.
3. Applicant stated that the wells will be drilled from no more than two well pads, to be located within such unit or adjacent thereto, unless an exception is granted by the Director.

- On September 15, 2014, the Commission entered Order 535-529, which among other things, established an approximate 1,280-acre drilling and spacing unit in Sections 27 and 34, Township 8 North, Range 60 West, 6th P.M., and approved eight horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.

- Rule 318.a. requires that wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and 1,200 feet from any other producible or drilling oil or gas well that has the same common source of supply. The Application Lands are subject to this Rule for the Fort Hays, Carlile, and Codell Formations.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of October 16, 2017, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
