AMENDED NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

APPLICATION LANDS

Township 7 South, Range 94 West, 6th P.M.
Section 19: Lots 1-4, E $\frac{1}{2}$ W $\frac{1}{2}$, E $\frac{1}{2}$ (All)

APPLICATION

On August 31, 2017, (amended June 20, 2018), Caerus Piceance LLC (Operator No. 10456) ("Caerus" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate all 40-acre drilling and spacing units established by Order No. 139-73 for Section 19, Township 7 South, Range 94 West, 6th P.M.;
- 2) Maintain 40-acre spacing within the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 19, Township 7 South, Range 94 West, 6th P.M., for the Rulison Federal #19-41C (17M) Well only under Order No. 139-73 and exclude the Well from the proposed drilling and spacing unit; and
- 3) Establish one approximate 600-acre drilling and spacing unit for the Application Lands for the production of oil, gas, and associated hydrocarbons from the Williams For and Iles Formations and authorizing one well per 10 acres within the unit with the bottom-hole locations of the permitted wells to be located no closer than 100 feet from the north and south unit boundaries, and no closer than 600 feet from the east and west unit boundaries, without exception being granted by the Director.

- On May 10, 2007, the Commission entered Order No. 139-73, which among other things, established various 40-acre drilling and spacing units for certain lands, including Section 19, Township 7 South, Range 94 West, 6th P.M., and approved the equivalent of one well per 10 acres within each 40-acre unit, for the production of oil, gas and associated hydrocarbons from the Williams Fork and Iles Formations.
