APPLICATION

On August 31, 2017, Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1. Pool all interests in two approximate 640-acre designated horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2. Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Johnsons Corner 12-C Well (API No. 05-069-06456) (Codell Formation – WSU No. 1) and the Johnsons Corner 13-N Well (API No. 05-069-06464) (Niobrara Formation – WSU No. 2) ("Wells").
