APPLICATION

On August 31, 2017, SRC Energy Inc. (Operator No. 10311) ("SRC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1. Amend Pooling Order No. 407-1716, but only as to Wellbore Spacing Units Nos. 1 and 3, to pool all interests in Wellbore Spacing Units Nos. 1 and 3 established for the Application Lands (consisting of the Original and Additional Lands), for development and operation of the Niobrara Formation.

2. Providing that the interests of any owners within the Additional Lands with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Bestway 14-2-11-14NAHZM Well and the Bestway B-2-11-14NBHZM Well, are made subject to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date the costs specified in §34-60-116(7)(b), C.R.S. are first incurred for the drilling of the Bestway 14-2-11-14NAHZM Well and the Bestway B-2-11-14NBHZM Well.

- On or about June 6, 2016, the Commission entered Order No. 407-1716 which, among other things, pooled all interests in three approximate 567.263-acre designated horizontal wellbore spacing units, covering the Original Lands, for the development and operation of the Niobrara Formation.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of January 15, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
