On August 31, 2017, Kerr-McGee Oil & Gas Onshore LP (Operator No. 47120) ("Kerr-McGee" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1. Pool all interests in two approximate 240-acre and six approximate 480-acre designated horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2. Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Burge 1C-2HZ Well (API No. 05-123-43813) (Codell Formation – WSU No. 1), the Burge 1N-2HZ Well (API No. 05-123-43818) (Niobrara Formation – WSU No. 2), the Burge 26N-2HZ Well (API No. 05-123-43816) (Niobrara Formation – WSU No. 3), the Burge 27C-2HZ Well (API No. 05-123-43815) (Codell Formation – WSU No. 4), the Burge 27N-2HZ Well (API No. 05-123-43819) (Niobrara Formation – WSU No. 5), the Burge 28N-2HZ Well (API No. 05-123-43814) (Niobrara Formation – WSU No. 6), the Burge 2C-2HZ Well (API No. 05-123-43812) (Codell Formation – WSU No. 7), and the Burge 2N-2HZ Well (API No. 05-123-43817) (Niobrara Formation – WSU No. 8) ("Wells").

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of October 16, 2017, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
