APPLICATION

On October 4, 2017, Bison Oil & Gas II, LLC (Operator No. 10661) ("Bison") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Modify Order No. 535-92 to include the Ft. Hays, Codell and Carlile Formations;
- 2) Approve a total of twenty horizontal wells for development of the Application Lands;
- 3) Require the productive interval of the wellbore of each wellbore in the unit to be no closer than 600 feet from the unit boundary, and no closer than 100 feet from the productive interval of any other wellbore located in the unit; and
- 4) Allow the drilling of the wells from no more than three (3) well pads located within the unit or at a legal location on adjacent lands, without exception granted by the Director.

The Application Lands are subject to the following COGCC Rules and Orders:

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.

- On October 31, 2011, the Commission entered Order No. 535-92, which established two approximate 640-acre drilling and spacing units for Section 14 and Section 15, Township 8 North, Range 61 West, 6th P.M., and approved up to two horizontal wells in each unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara Formation, with the treated interval of the wellbores to be located no closer than 600 feet from the unit boundaries, and no closer than 1,200 feet from the treated interval of any other wellbore, without exception being granted by the Director.

NOTICE IS HEREBY GIVEN, pursuant to §§ 34-60-101 to -130, C.R.S., and the Commission's Rules of Practice and Procedure, 2 CCR 404-1, that the Commission has scheduled this matter for hearing on:

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of November 27, 2017, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Commission Rule 511, if the matter is uncontested, it may be approved without a hearing.
