APPLICATION

On October 12, 2017, SRC Energy Inc., Operator No. 10311 ("SRC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1040.2-acre drilling and spacing unit for the Application Lands, for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations;
- 2) Approve the drilling of fifteen horizontal wells in the proposed unit, to be drilled in a general east/west orientation, and
- 3) Allow the treated intervals of the wellbores to be no closer than 460 feet from the boundaries of the unit, with an inter-well setback no closer than 150 feet from the treated interval of a well producing from the same formation.
- 3) Applicant states that any horizontal wells to be drilled in the unit will be drilled from no more than two multi-well pads on the surface of the drilling unit, or on adjacent lands with consent of the landowner, unless an exception is granted by the Director.
