On October 12, 2017, (amended November 6, 2017) Noble Energy, Inc. (Operator No. 100322) ("Noble" or "Applicant"), filed a verified amended application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in two approximate 720-acre drilling and spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Bison Ridge Y22-749, API No. 05-123-45379;
- b. Bison Ridge Y22-756, API No. 05-123-45370.
