2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Boomerang 25N-3A-L Well (05-123-46000)
- b. Boomerang 25N-3B-L Well (05-123-45999)
