APPLICATION

On November 30, 2017, Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in three approximate 636.518-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the RBF 1 Well (API No. 05-123-44448) (WSU No. 1); RBF 2 Well (API No. 05-123-44446) (WSU No. 2) and the RBF 3 Well (API No. 05-123-44441) (WSU No. 3).
