APPLICATION

On November 30, 2017, Extraction Oil & Gas, Inc., Operator No. 10459 ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in five approximate 637.1593-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the RBF 5 Well (API No. 05-123-44439) (WSU No. 1); RBF 6 Well (API No. 05-123-44443) (WSU No. 2); RBF 7 Well (API No. 05-123-44445) (WSU No. 3); RBF 8 Well (API No. 05-123-44440) (WSU No. 4); and the RBF 9 Well (API No. 05-123-44449) (WSU No. 5).


