APPLICATION

On November 30, 2017, Extraction Oil & Gas, Inc., Operator No. 10459 ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in five approximate 878.84-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Johnsons Corner East 2C Well (API No. 05-069-06460) – Codell Formation (WSU No. 1); Johnsons Corner East 3N Well (API No. 05-069-06457) – Niobrara Formation (WSU No. 2); Johnsons Corner East 4N Well (API No. 05-069-06463) – Niobrara Formation (WSU No. 3); Johnsons Corner East 5C Well (API No. 05-069-06468) – Codell Formation (WSU No. 4); and the Johnsons Corner East 6N Well (API No. 05-069-06466) – Niobrara Formation (WSU No. 5)
