On January 18, 2018 (amended on February 12, 2018), Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in two approximate 641.337-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Milkshake 31W-20-16N (API No. 05-123-46053);
- b. Milkshake 31W-20-17N Well (API No. 05-123-46056).
