On January 18, 2018, Kerr-McGee Oil & Gas Onshore LP (Operator No. 47120) ("Kerr-McGee" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in two approximate 200-acre designated horizontal wellbore

spacing units, two approximate 400-acre horizontal wellbore spacing units, and one approximate 360-acre horizontal wellbore spacing unit, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Azul 13-3HZ Well (API No. 05-123-45917);
- b. Azul 13-4HZ Well (API No. 05-123-45913);
- c. Azul 13-9HZ Well (API No. 05-123-45908);
- d. Azul 13-11HZ Well (API No. 05-123-45914); and
- e. Azul 13-12HZ Well (API No. 05-123-45909).
