On January 18, 2018, Kerr-McGee Oil & Gas Onshore LP (Operator No. 47120) ("Kerr-McGee" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in three approximate 400-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:
 - a. Azul 13-27HZ Well (API No. 05-123-46118);
 - b. Azul 13-28HZ Well (API No. 05-123-46109); and
 - c. Azul 13-29HZ Well (API No. 05-123-46116).
