On February 26, 2018, Petitioners Gary Ohlson and Kary Tykeson-Ohlson ("Petitioners") filed a Petition for Review on February 26, 2018 regarding the presence of benzene and other contaminants in their family's drinking water well located at their residence, 36105 East 124<sup>th</sup> Avenue, Adams County, Colorado. The Ohlsons' Petition for Review challenges the closure of their complaint and requests that The Colorado Oil and Gas Conservation Commission ("COGCC") order COGCC staff to perform additional investigation to determine the source of the benzene and other contaminants in their drinking water well. BP America Production Company (Operator No. 10000) ("BP") and COGCC Staff oppose the Petition for Review.

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 16, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
