APPLICATION

On March 1, 2018, Enerplus Resources (USA) Corporation (Operator No. 10177) ("Enerplus" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in an approximate 1,280-acre drilling and spacing unit, established for the Application Lands, for the development and operation of the Niobrara, Fort Hays, Codell, and Carlile Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Avignon 8-67-32-31C Well (API No. Pending);
- b. Bergerac 8-67-32-31C Well (API No. Pending);
- c. Calais 8-67-32-31C Well (API No. Pending);
- d. Dijon 8-67-32-31C Well (API No. Pending);
- e. Ermont 8-67-32-31C Well (API No. Pending);
- f. Grenoble 8-67-32-31C Well (API No. Pending);
- g. Narbonne 8-67-32-31N Well (API No. Pending); and
- h. Nantes 8-67-32-31N Well (API No. Pending).

- On March 19, 2018, the Commission entered an order in Docket No. 180100061 (Order No. Pending), which, among other things, established an approximate 1,280-acre drilling and spacing unit for the Application Lands, and approved eight horizontal wells within the

unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations.


