APPLICATION

On March 1, 2018, Enerplus Resources (USA) Corporation (Operator No. 10177) ("Enerplus" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Declare Order No. 535-825, pooling all interests in an approximate 640-acre drilling and spacing unit established for the Application Lands applicable to all previously unnoticed parties.

- On June 12, 2017, the Commission entered Order No. 535-825 which, among other things, pooled all interests in an approximate 1,280-acre drilling and spacing unit for the Application Lands, for the development and operation of the Niobrara, Fort Hays, Codell, and Carlile Formations, and to subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the Horsetooth 8-67-28-27C Well (formerly known as the Barely Wine 8-67-28-27C Well) (API No. 05-123-44597), the Carter 8-67-28-27C Well (formerly known as the Bittier 8-67-28-27C Well) (API No. 05-123-44596), the Dillon 8-67-28-27C Well (formerly known as the Brown Ale 8-67-28-27C Well) (API No. 05-123-44594), the Stagecoach 8-67-28-27C Well (formerly known as the ESB 8-67-28-27C Well) (API No. 05-123-44592), the Hanging 8-67-28-27C Well (formerly known as the IPA 8-67-28-27C Well) (API No. 05-123-44599), the Bear Creek 8-67-28-27C Well (formerly known as the Mild Ale 8-67-28-27C Well) (API No. 05-123-44598), the Cherry Creek 8-67-28-27N Well (formerly known as the Old Ale 8-67-28-27N Well) (API No. 05-123-44595), and the Chatfield 8-67-28-27N Well (formerly known as the Stout 8-67-28-27N Well) (API No. 05-123-44593) ("Wells").



One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 16, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
