APPLICATION

On March 1, 2018, Edge Energy II, LLC (Operator No. 10671) (“Edge” or “Applicant”) filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate Order No. 535-147, only as it pertains to the Application Lands;

2) Provide that the Black Hollow 8-67-16 #3H (API No. 05-123-35397), an existing horizontal well located in Section 16, Township 8 North, Range 67 West, 6th P.M., continue paying to its existing approximate 640-acre drilling and spacing unit;

3) Establish four approximate 1,280-acre drilling and spacing units and approve a total of up to 12 horizontal wells for the production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations;

4) Establish well location rules requiring the productive interval of the wellbore of any permitted wells in the unit be located no closer than 600 feet from the unit boundary, and no closer than 150 feet from the productive interval of any other wellbore located in the unit.

APPLICABLE ORDERS AND RULES

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.
- On March 8, 2012, the Commission issued Order No. 535-147, which established eight approximate 640-acre drilling and spacing units for certain lands located Townships 8 and 9 North, Ranges 59 through 64 West, 6th P.M., and allow one horizontal well in each of the units, for the production of gas and associated hydrocarbons from the Niobrara Formation.

NOTICE IS HEREBY GIVEN, pursuant to §§ 34-60-101 to -130, C.R.S., and the Commission's Rules of Practice and Procedure, 2 CCR 404-1, that the Commission has scheduled this matter for hearing on:

later than April 16, 2018. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 16, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
