APPLICATION

On March 1, 2018, Edge Energy II, LLC (Operator No. 10671) (“Edge” or “Applicant”) filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate Order Nos. 535-2 and 535-7, only as they pertain to the Application Lands;
- 2) Establish two approximate 1,280-acre drilling and spacing units and approve a total of up to 12 horizontal wells for the production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations;
- 3) Establish well location rules requiring the productive interval of the wellbore of any permitted wells in the unit be located no closer than 600 feet from the unit boundary, and no closer than 150 feet from the productive interval of any other wellbore located in the unit.

APPLICABLE ORDERS AND RULES

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located

not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.

- On August 12, 2010, the Commission issued Order No. 535-2, which established 145 approximate 640-acre drilling and spacing units for certain lands located in Township 8 North, Range 67 West, 6th P.M., Townships 8 through 10 North, Range 66 West, 6th P.M., and Townships 8 through 11 North, Range 67 West, 6th P.M., for the production of gas and associated hydrocarbons from the Niobrara and Codell Formations.
- On April 4, 2011, the Commission issued Order No. 535-7 which established 51 approximate 640-acre drilling and spacing units for certain lands located Townships 9 through 11 North, Ranges 64 through 67 West, 6th P.M., and allow one horizontal well in each of the units, for the production of gas and associated hydrocarbons from the Niobrara Formation.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 16, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
