APPLICATION

On April 12, 2018, Enerplus Resources (USA) Corporation (Operator No. 10177) ("Enerplus" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in an approximate 1,280-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Niobrara, Fort Hays, Codell, and Carlile Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Deerfoot Trail 7-67-3-34N Well (API No. to be assigned);
- b. Memorial 7-67-3-34N Well (API No. to be assigned);
- c. Crowchild 7-67-3-34C Well (API No. to be assigned);
- d. Macleod Trail 7-67-3-34C Well (API No. to be assigned);
- e. Glenmore Trail 7-67-3-34C Well (API No. to be assigned);
- f. Sarcee 7-67-3-34C Well (API No. to be assigned);
- g. Bow Trail 7-67-3-34C Well (API No. to be assigned); and
- h. McKnight 7-67-3-34C Well (API No. to be assigned).

- On January 29, 2018, the Commission entered Order Nos. 407-2359 and 535-939 which, among other things, established an approximate 1,280-acre drilling and spacing unit, and approved the drilling of two horizontal well within the unit from the Niobrara Formation and six horizontal wells within the unit for production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations, and require the productive interval of the wellbore to be located no closer than 600 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore producing from the same source of supply within the unit, with the horizontal wells to be drilled from no more than two multi-well pads on the surface of the drilling unit, or on adjacent lands with consent of the landowner, unless an exception is granted by the Director.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of May 28, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
