APPLICATION

On April 11, 2018, (amended May 2, 2018), PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant"), filed a verified application pursuant to § 34-60-116, C.R.S., for an order to:

1) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands, and approve up to 18 horizontal wells in the proposed unit, for production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations, with the productive interval of any wellbore permitted under this Application located not less than 150 feet from the east and west unit boundaries, and no closer than 460 feet from the north and south unit boundaries, and not less than 150 feet from the productive interval of any well producing within the same unit, unless an exception is granted by the Director; and;

2) Require that the wells be drilled from no more than three surface locations within the unit or on adjacent lands, unless an exception is granted by the Director.

3) Provide that any permitted wells shall be drilled in an east-west orientation or a west-east orientation.

- On April 27, 1998, the Commission adopted Rule 318A, which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well, and to commingle any or all of the Cretaceous Age formations from the base of the Dakota Formation to the surface. Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of Greater Wattenberg Area wells. On December 5, 2005, Rule 318A was amended, among other

things, to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended, among other things, to address drilling of horizontal wells. The Application Lands are subject to Rule 318A for the Niobrara and Codell Formations.

- On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara Formations, the Codell Formation, and the Niobrara Formation underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order 407-1. The Application Lands are subject to this Order.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of May 28, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
