APPLICATION

On April 12, 2018, SRC Energy Inc. (Operator No. 10311) ("SRC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,908-acre drilling and spacing unit for the Application Lands, and approving the drilling of 44 horizontal wells within the proposed unit, for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations, with the treated intervals of any horizontal well permitted under this Application located not less than 460 feet from unit boundaries and not less than 150 feet from the treated interval of a well producing from the Niobrara and Codell Formations, unless an exception is granted by the Director; and
- 2) Require that the wells be drilled from no more than four well pads located within the unit or on adjacent lands.

- On April 27, 1988, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule, which was amended on August 8, 2011 to, among other things, address the drilling of horizontal wells and requires that a horizontal wellbore spacing unit must include any governmental quarter-quarter section that are located less than 460' from the completed interval of the wellbore lateral. Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of the Greater Wattenberg Area. The Application Lands are subject to Rule 318A for the Codell and Niobrara Formations.
