1) Pool all interests in two approximate 735.07-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Greeley-Rothe 34N-2B-L Well (API No. 05-123-46448);
- b. Greeley-Rothe 34C-2-L Well (API No. 05-123-46447).
