APPLICATION

On April 12, 2018, Confluence DJ LLC (Operator No. 10518) (“Confluence” or “Applicant”), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in the Application Lands underlying an approximate 1,280-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Desha 4-10-2L Well (API No. to be assigned) (“Well”).

APPLICABLE RULES AND ORDERS

- On April 27, 1988, the Commission adopted Rule 318A, which among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all of the Cretaceous Age Formations from the base of the Dakota Formation to the surface. On December 5, 2005, Rule 318A. was amended to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A. was again amended to, among other things, address drilling of horizontal wells. The Application Lands are subject to Rule 318A.
- At the Commission’s April 30 – May 1, 2018 Hearing, the Commission ordered in Docket No. 171000719, among other things, to establish an approximate 1,280-acre drilling and spacing unit, and authorize the drilling of up to 20 horizontal wells for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of May 28, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
