NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

APPLICATION LANDS

Township 8 North, Range 60 West, 6th P.M.
Section 3: All

On May 4, 2018, (amended May 21, 2018), Mallard Exploration, LLC (Operator No. 10665) and Noble Energy, Inc. (Operator No. 100322) (together as Co-Applicants), filed a verified application ("Application"), pursuant to §34-60-116, C.R.S., for an order to:

1) Amend Order No. 535-3 to establish an approximate 640-acre drilling and spacing unit for the Application Lands, and approve the drilling of an additional 15 horizontal wells within said unit, for a total of 16 horizontal wells, for production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations, with the productive interval of any permitted horizontal well located no closer than 600 feet from the boundaries of the proposed unit (regardless of lease lines within the unit), and no closer than 150 feet from the productive interval of any other wellbore within the unit, unless an exception is granted by the Director.

2) Limit the drilling of any permitted wells under this Application to no more than two new well pads in the unit, or on lands adjacent thereto with surface owner consent, unless an exception is granted by the Director.

APPLICABLE ORDERS AND RULES

- COGCC Rule 318.a. provides that for any oil or gas well drilled to a common source of supply and drilled to a producing depth at least 2,500 feet below ground surface shall be located not less than 600 feet from any lease line and not less than 1,200 feet from any other producing or drilling oil or gas well when drilling to the same source of supply, unless approved by Commission order upon hearing. The Application Lands are subject to this Rule for production of oil and gas from the Niobrara, Fort Hays and Carlile Formations.
- On October 28, 2013, the Commission entered Order No. 535-3 which, among other things, established an approximate 640-acre drilling and spacing unit for the Application Lands, and approved one horizontal well within said unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation. The Application Lands are subject to this Order for the Niobrara Formation.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 16, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
