APPLICATION

On May 31, 2018, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests in ten (10) approximate 1040-acre designated wellbore spacing units established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Seltzer LD 21-033HC (API No. Pending); Seltzer LD 21-033HN (Doc. No. 401490097); Seltzer LD 21-034HN (API No. Pending); Seltzer LD 21-034HNX (API No. Pending); Seltzer LD 21-036HC (API No. Pending); Seltzer LD 21-036HN (API No. Pending); Seltzer LD 21-037HN (API No. Pending); Seltzer LD 21-037HNX (API No. Pending); Seltzer LD 21-039HC (API No. Pending); and Seltzer LD 21-039HN (API No. Pending) ("Wells").

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which, among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara

Formations, the Codell Formation, and the Niobrara Formation underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order No. 407-1.
