APPLICATION

On August 27, 2018, amended September 20, 2018, Kerr-McGee Oil & Gas Onshore LP (Operator No. 47120) ("Kerr-McGee" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests in three approximate 880-acre designated horizontal wellbore spacing unit, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:
  - a. English Farms 8-5HZ Well (05-123-46526) – Codell Formation – WSU No. 1;
  - b. English Farms 8-6HZ Well (05-123-46525) – Niobrara Formation – WSU No. 2;
  - c. English Farms 8-7HZ Well (05-123-46521) – Niobrara Formation – WSU No. 3.
