On August 30, 2018, (amended September 20, 2018), SRC Energy, Inc. (Operator No. 10311) ("SRC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Amend Order Nos. Order Nos. 407-2314 and 407-2488 to include the Application Lands; and
- 2) Modify the setbacks for the Application Lands such that for any permitted wells to be drilled, the productive interval of the wellbore will be not less than 150 feet from the western boundary of the drilling and spacing unit and not less than 460 feet from the northern, southern, and eastern boundaries of the drilling and spacing unit, with an inter-well setback of no closer than 150 feet from the productive interval of any other wellbore producing from the same source of supply within the unit, unless the Director grants an exception.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On January 29, 2018, the Commission entered Order No. 407-2314 which, among other things, established an approximate 2,240-acre drilling and spacing unit for Sections 7 and 8, Township 5 North, Range 66 West, 6th P.M., and Sections 11 and 12, Township 5 North, Range 67 West, 6th P.M., and approved 40 horizontal wells within the unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations.
- On June 11, 2018, the Commission entered Order No. 407-2488, in which the Commission declared Order No. 407-2314 applicable to previously unnoticed parties.
